**The purposes of processing personal data and the legal basis for processing**

Personal data of people contacting "Power." Sp. z o.o. are processed in order to:

- implementation of the law,
- keeping current correspondence, answering questions, providing information about Power Sp.z o.o.
- for marketing and commercial purposes of the Administrator. The legal basis for the processing of personal data is art. 6 par. 1 lit. b and c of the general data protection regulation 2016/679 (GDPR) or consent of the data subject (Article 6 (1) (a) of the General Data Protection Regulation 2016/679 (GDPR).

Providing personal data is voluntary, but it may be necessary to achieve the goal.

**Information about recipients of personal data**

Personal data of people contacting "Power." Sp. z o.o. they may be transferred to entities authorized under the law and to technical and organizational service providers, in particular ICT services, as well as courier and postal services.

**The period during which personal data will be stored**

Personal data of people contacting "Power." Sp. z o.o. are kept for a period of time required by law or until withdrawal of consent.

**Rights due to the processing of personal data**

Persons contacting "Power." Sp. z o.o. You have the right to request access to your personal data, and in case of necessity, to correct, delete or limit their processing or object to their processing and the right to transfer data if the processing takes place in an automated manner. If the processing of personal data is based on consent, the person contacting "Power." Sp z o. o. has the right to submit a statement of withdrawal of any consent given at any time. Withdrawal of consent does not affect the legality of the processing, which was made on the basis of consent before its withdrawal.

Providing some personal data for current correspondence and answering questions or information about Administrator services, such as, for example, email address, first and last name or telephone

number is a prerequisite for conducting correspondence, and failure to do so may cause that the Administrator will not be able to effectively provide the above information.

**Information on the right to lodge a complaint to the supervisory body**
